### SECTION 4: FIRST AID MEASURES

#### 4.1. DESCRIPTION OF FIRST AID MEASURES

##### INHALATION

### SECTION 7: HANDLING AND STORAGE

#### 7.1. PRECAUTIONS FOR SAFE HANDLING

Avoid breathing mists or vapor. Prevent small spills and leakage to avoid slip hazard. Material can accumulate static charges which may cause an electrical spark (ignition source).
